Copyright

 I have read and agree to the following statements: As a client of kaeproductions, I acknowledge and understand that the images taken by kaeproductions, PHOTOGRAPHER; Kujueria Tate, are protected by Federal Copyright Laws. I understand it is ILLEGAL to copy or reproduce the photographs taken by kaeproductions elsewhere without the PHOTOGRAPHER's permission, and violators of this Federal Law will be subject to its civil and criminal penalties. Reproduction includes, but is not limited to scanning, downloading, right-clicking, emailing, saving to hard drive(s), posting on websites, blog or social media, photocopying, obtaining screen shots, or printing in any manner, without the consent from the PHOTOGRAPHER. The PHOTOGRAPHER's permission will be supplied in the form of a limited PRINT RELEASE with the purchase of full resolution digital images from the client's proofs, to print your portraits for your own **personal use**, download to your hard drive(s), and sharing online on social media. The print release does not allow publication of your portraits for commercial use (i.e. entering in contests or magazine publications), or selling or altering your images without the PHOTOGRAPHER's permission. I agree to honor the copyright laws as stated in this agreement.

Print Release

 I have read and agree to the following statements: A print release is included with purchase of digital files. The print release does not allow publication of your portraits (i.e. entering in contests or magazines), or selling or altering of your images without the photographer's written permission. It is illegal to copy, scan, download, print, share, alter, obtain screen shots, or otherwise steal any image created by kaeproductions during client's photo session without the PHOTOGRAPHER's written permission. Sharing on personal social media pages, web pages, or blogs is allowable but credit and link back to kaeproductions' social media page (Facebook, Instagram, or www.kaeproductions.com) is required.

Refunds, Reshoots, and Cancellations

• I have read and agree to the following statements: Re-shoots will be determined at the discretion of the PHOTOGRAPHER and discussed with the CLIENT. Re-shoots and refunds will not be given for poor choices of clothing, makeup, hair or weather-related issues, or by not following the recommendations of the photographer. If a retainer fee was used to book the session, it is not refundable and it is applied to your session fee. There shall be no refund of deposit fee after the signing of this Agreement and the reservation of the photography date unless an Act of God occurs. The session fee is not refundable once images have been captured by PHOTOGRAPHER, have been delivered, or downloaded. Print fees are not refundable once proof has been approved and prints ordered. Any special circumstance shall be discussed between the Client and the Photographer. All arrangements will be put in writing. Cancellation must be in writing even if a phone call was made to inform the Photographer of the cancellation.

Payment

• I have read and agree to the following statements: All payments are due in full at least 1-2 days before the session unless other payment arrangements have been made. Payment arrangements will be stated in writing via paper or electronic signature. Session will not take place until the complete balance in full is received. Images will not be processed and/or prints will not be ordered until payment in full is received for print and product orders. Once a balance is paid, it is non-refundable.

Damages

 I have read and agree to the following statements: Photographer is not responsible for the damage of portraits or discs after delivery to client, including damage caused during transit by US mail. Client assumes all responsibility for the safety of all portraits upon receipt and for the safety of their belongings.

Liability

• I have read and agree to the following statements: Photographer is not responsible for any injuries inflicted upon any participating parties, before, during, or after session. Client(s) will be responsible for their children and for themselves and release photographer from any claims against their person, their property, or their business.

Session Deposit/Retainer Fee

- I have read and agree to the following statements: A non-refundable retainer/deposit fee is due upon booking in order to reserve your Session unless stated that the total balance is due at time of booking. All remaining balances are due no later than 24 hours before the session date and time. No part of any order, including proofs, will be delivered until the balance is paid in full. If session is not paid in full by the time the session is to start, Photographer reserves the right to not perform any photography work or even show up for the session. Your desired session is not reserved until the retainer fee is received full and clear. Therefore, in order to avoid any overbooking, the deposit fee is non-refundable. If you cancel with less than 48 hour notice, you forfeit your retainer fee and may not reschedule without a new retainer fee. Re-scheduling may occur to save your deposit if you give at least 48 hours notice and the session is rescheduled within the calendar year of the original reserved date, or if there is a family emergency or serious illness. Re-scheduling of the session due to bad weather may occur at photographer's discretion for the best interest of your desires for your session.
